Dear Parent/Guardian;

We are very excited to propose offering Spanish 101 (Elementary Spanish), a Bristol Community College course taught by one of their professors for Tri-County students. These college course offerings will take place after school in the Fall Semester (Sept-Dec). Students will need to meet specific prerequisites and agree to the time commitment. These courses will be taught at a college level and pace, and with a passing grade will result in three transferable college credits. This is **not** a Tri-County RVTHS course. It is a BCC course offered to Tri-County students with **limited** parent involvement, abiding by BCC student code of conduct, **not** Tri-County Student Handbook.

**Course Name:** Elementary Spanish 101

**Location:** Hybrid, Class time at TC after school (Once/week) **then** home meetings and assignments

**Time Commitment:** Approximately 45 class hours (not including take-home assignments and studying)

**Duration:** September to December (Make-up dates due to weather TBD)

**Meeting Time:** TBD

**GPA/Class Rank:** completed courses will be added to the Tri-County Transcript and will be weighted as a 6-credit honors level class.

If the number of students interested exceeds the number of seats available, administration will determine the roster based on grade level, grades, attendance, and intent. If a student is granted permission to withdraw or is asked to withdraw (s)he will have a transcript that will include a withdrawal/failing grade and the book fee will not be refunded. Students will not be able to take this course and participate in Cooperative Education simultaneously, unless the employer agrees to this schedule.
